Pulmonary edema may occur with tightness in the chest, shortness of breath, bluish skin, decreased blood pressure, and increased heart rate. Inhaled corrosive substances can lead to a toxic edema of the lungs. Pulmonary edema can be fatal. Harmful by inhalation.

##### **Eye contact**

Causes burns. Corrosive to the eyes and may cause severe damage including blindness. Causes serious eye damage. May cause irreversible damage to eyes.

##### **Skin contact**

Toxic in contact with skin. Corrosive. Causes severe burns. Avoid contact with skin and clothing.
