### 4. FIRST AID MEASURES

#### Description of first aid measures

##### General advice

Immediate medical attention is required. Show this safety data sheet to the doctor in attendance.

##### Inhalation

Remove to fresh air. If breathing has stopped, give artificial respiration. Get medical attention immediately. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Inhaled corrosive substances can lead to a toxic edema of the lungs. Pulmonary edema can be fatal.
<b>Eye contact</b>	Causes burns. Corrosive to the eyes and may cause severe damage including blindness. Causes serious eye damage. May cause irreversible damage to eyes.
<b>Skin contact</b>	Corrosive. Causes severe burns. Avoid contact with skin and clothing.
